



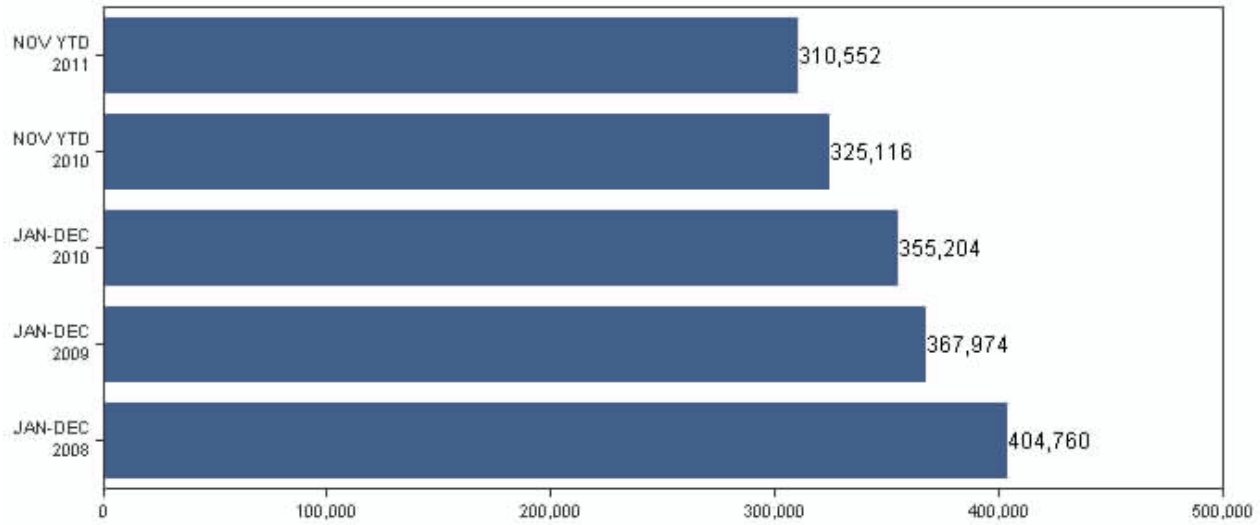

## Enplanements/Corpus Christi International Airport

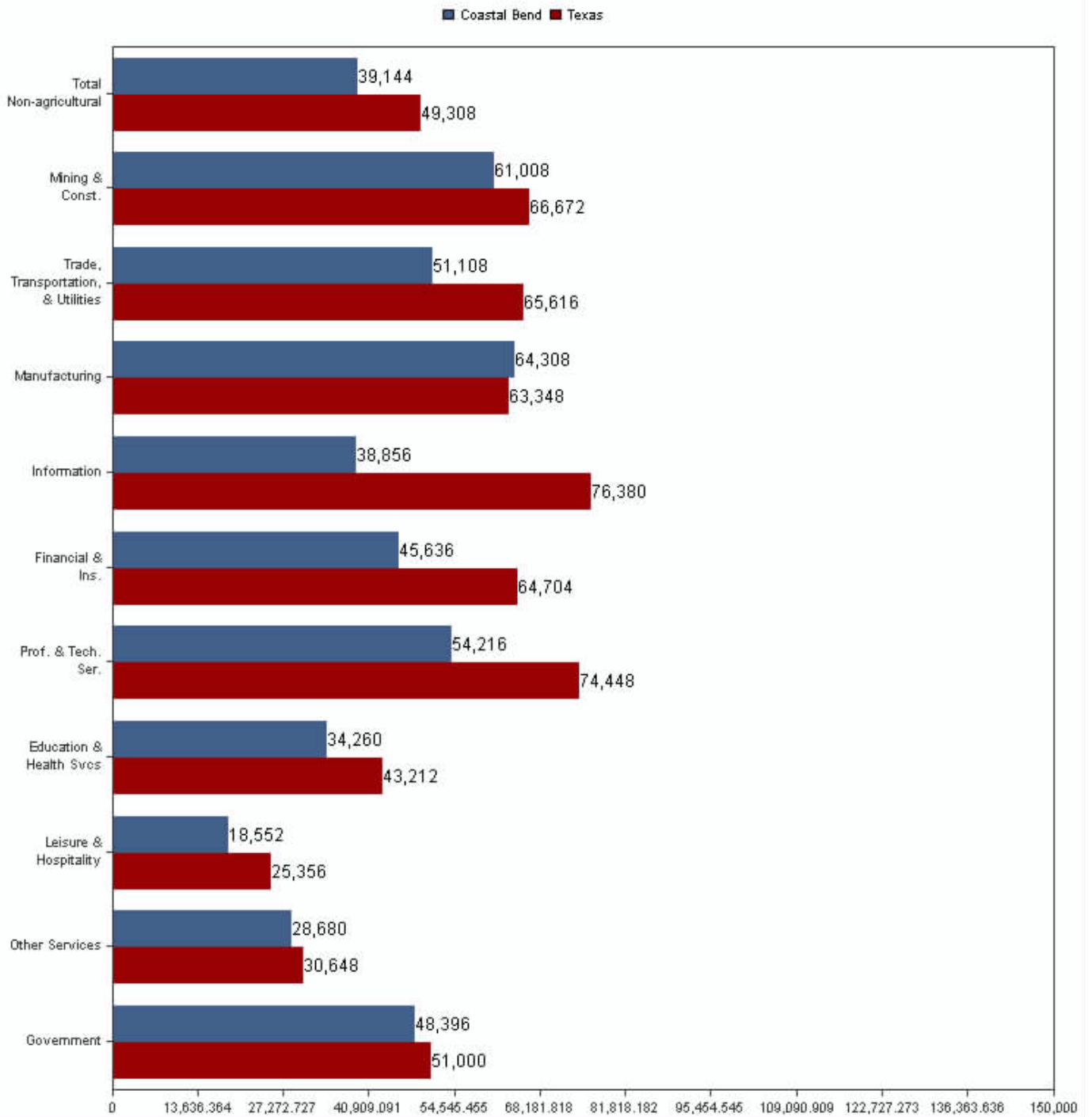

**Average Annual Wages 2nd Quarter 2011**

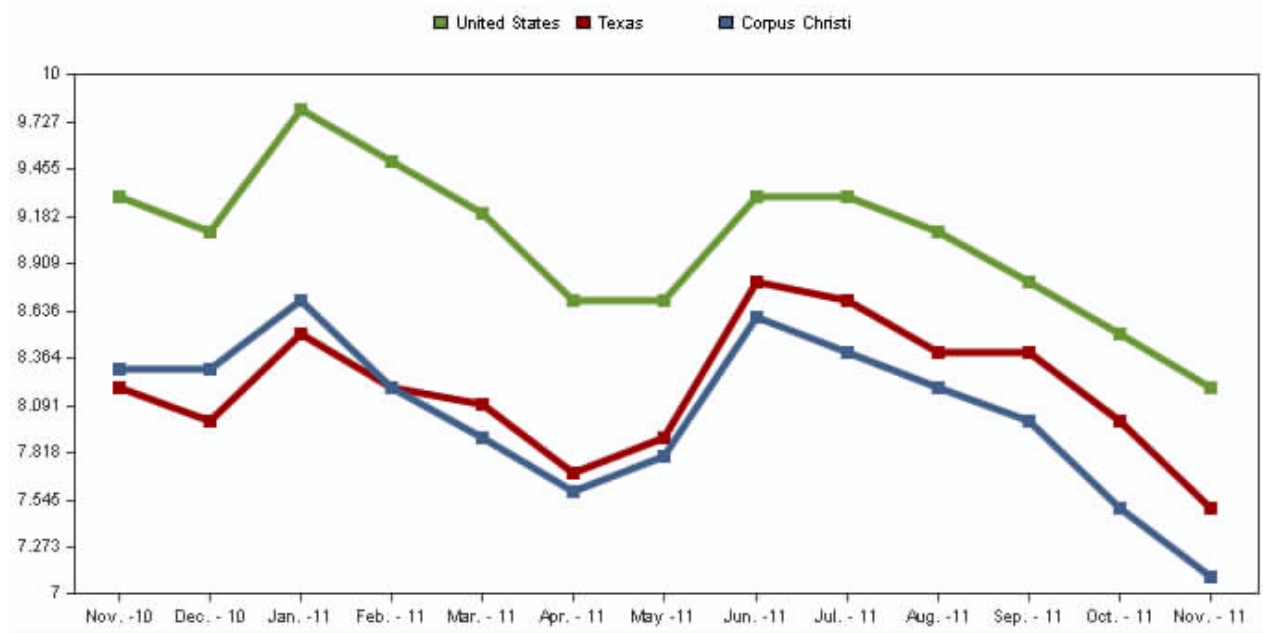
